But the irony is that the state or its authorities and related persons are taking Human Rights Education programme in a very casual manner. We see Human Rights are neglected across the globe. The universal declaration of Human Rights did not have force of power.

People are using the concept of Human Right in self evidentiary sense not in jurisprudence sense. Different people, group of people, nation, group of nations are developing the concept of human rights suitable to their needs and interests. Result of it, less positive results and more frustration. There prevails a tattered conditions of human rights all over the world where positive underpinnings are non existent.
